# Meeting Minutes

#### 1. In Attendance

### 2. EFAN Catchment Area

- The catchment area follows the Edmonton Capital Region boundaries and includes the following municipalities:
  - six cities: Edmonton, Fort Saskatchewan, Leduc, St. Albert, Beaumont and Spruce Grove;
  - one specialized municipality, Strathcona County, which includes Sherwood Park;
  - three municipal districts: Leduc County, Parkland County, and Sturgeon County;
  - nine towns: Bon Accord, Bruderheim, Calmar, Devon, Gibbons, Legal, Morinville, Redwater, and Stony Plain;
  - four villages: Spring Lake, Thorsby, Wabamun, and Warburg;
  - eight summer villages: Betula Beach, Golden Days, Itaska Beach, Kapasiwin, Lakeview, Point Alison, Seba Beach, and Sundance Beach;
  - four Indian Reserves for three First Nations: Alexander 134 of the Alexander First Nation, Stony Plain 135 of the Enoch Cree Nation, and Wabamun 133A and 133B of the Paul First Nation.

## 3. FASD Transitional Mentorship Program

- Outcomes-based correctional program intended to sustain or expand services through the In-Reach program.
- Target clients: 12+, with/possibly with FASD, involved with provincial correctional system.
- \$400,000/year for two years for entire province.

## 4. Co-Chairs and Executive Board

- If the Board uses Co-Chairs, their term shall be 2 years. Co-Chairs may be elected for a second term.

During the past fiscal year, EFAN's total income was \$6,224,146.00 against total expenses of \$6,223,935. Total assets \$508,342, total liabilities \$467,627, net assets \$40,715. These numbers represent the twelve months ended March 31, 2023.

# **10. New Research & Resources**

- Updated CanFASD 'Common Messaging Guide' has been released.
- This year, they have made a few changes, including:
  - A new preamble to increase **transparency about our process** for developing and updating the guide
  - Changes to the language we use to refer to the "costs" associated with FASD
  - A new section on **lived experience**
  - Major updates regarding **gender-inclusive** language (women and gender diverse persons or birthing parent(s)
  - New sections on neurodiversity and interdependence
- An important point to consider when using the guide is that a "one-size-fits-all" approach to language and messaging does not always apply. The suggestions made in the guide are intended to be inclusive and respectful for all individuals with FASD and their families. However, recognizing the diversity and uniqueness of each
