- *Frontline FASD Collective: Empowering Communities Through Collaboration* - The "Frontline FASD Collective: Empowering Communities Through Collaboration" meeting is convened with the aim of fostering a spirit of collaboration, shared expertise, and mutual support among dedicated frontline professionals. By fostering connections and knowledge exchange, we aim to drive positive change, reduce stigma, and ultimately improve the lives of individuals and families impacted by FASD. - Proposing a quarterly meeting, first to be held January 2024
